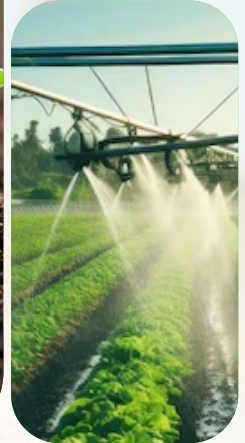

# WHY NIGERIA AGRITECH SPACE

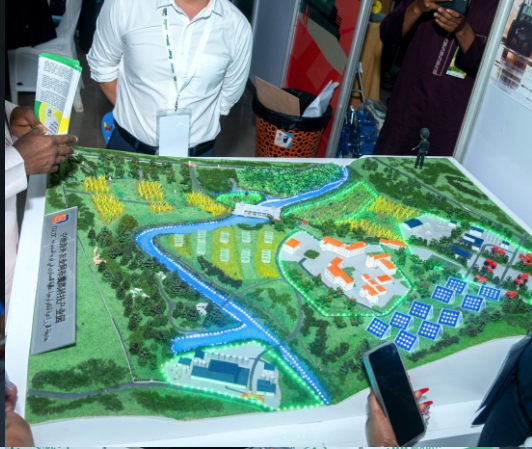

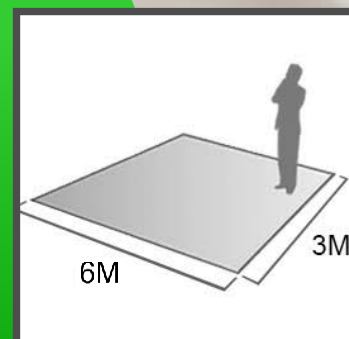

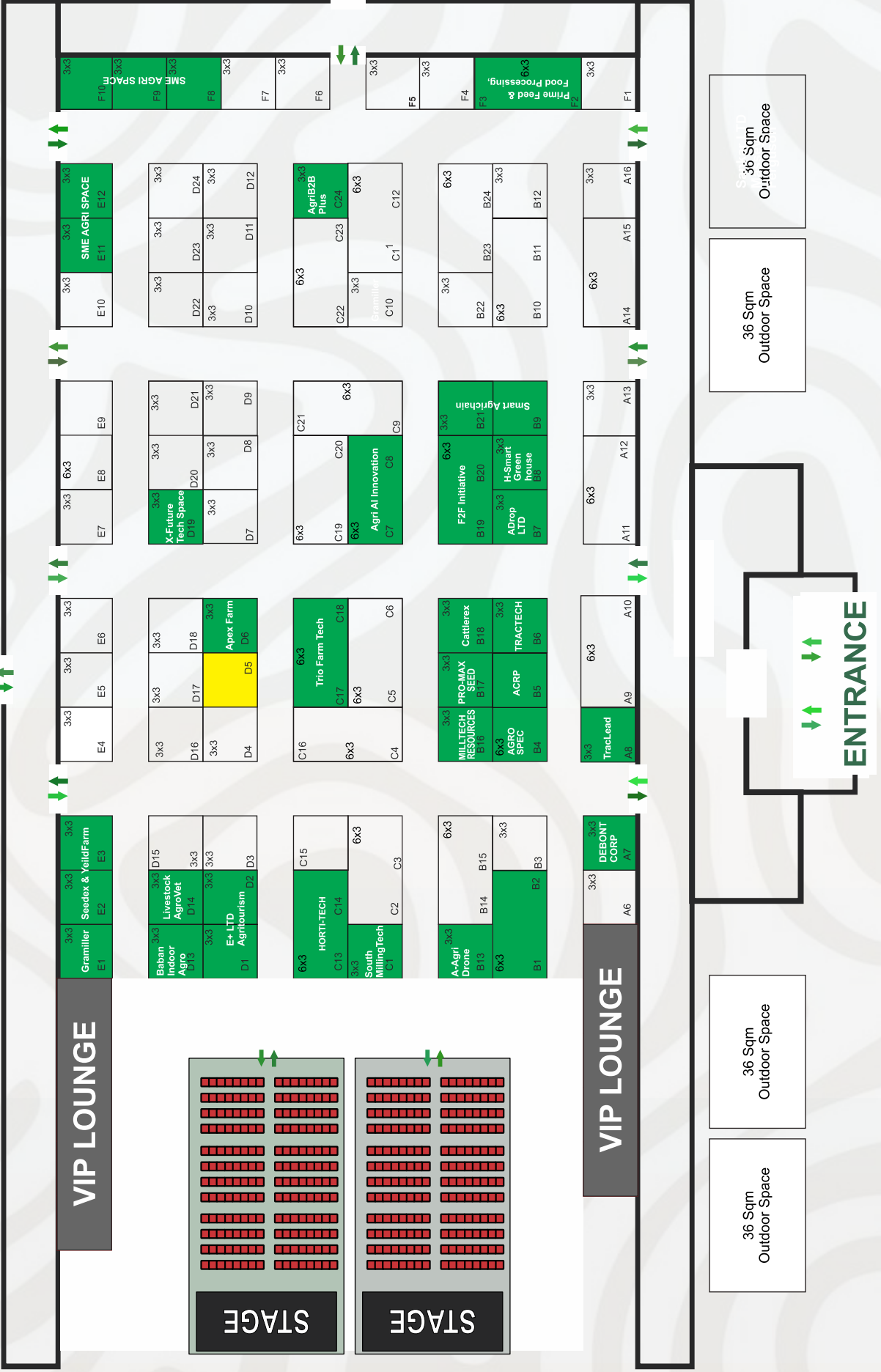
